

ALCOHOLIC BEVERAGE SAMPLING AND SELLING AUTHORIZATION FORM

Alcoholic beverage sales, service and sampling are regulated by the State of Indiana and the Memorial Coliseum's designated Concessionaire and on-premise caterer, currently Aramark, who is responsible for the facilitation of the regulations and dispensing of all alcoholic beverages. Sampling and selling of beer, wine or liquor is ONLY permitted with this completed form and a copy of the Temporary Craft Manufacturer Hospitality Permit.

The following conditions must be met to allow sampling and/or selling of alcoholic beverages at the Memorial Coliseum:

1. The winery/brewery/distillery would need to obtain a Temporary Craft Manufacturer Hospitality Permit (TCMHP) through the ATC (Indiana Alcohol & Tobacco Commission)
2. The winery/brewery/distillery may offer samples not to exceed one (1) ounce for wine, one-half (.5) ounce for liqueurs or cordials samples, four-tenths (.4) ounce for liquors, and six (6) ounces for beer samples.
3. The individual from the winery/brewery/distillery dispensing the product must have an Employee Permit (Liquor License) in the State of Indiana. A copy of the permit must be provided to Aramark and the Memorial Coliseum Senior Event Manager prior to the event.
4. The winery/brewery/distillery may not charge a fee to a consumer for a sample.
5. A copy of the winery/brewery/distillery's Proof of Liability Insurance listing the Memorial Coliseum as an additional insured must be provided to Aramark and the Memorial Coliseum Senior Event Manager prior to the event.
6. The winery/brewery/distillery are permitted to sell unopened bottles onsite. Bottles are to remain sealed.
7. The sale of alcoholic beverages by the glass from a winery/brewery/distillery is prohibited by the Memorial Coliseum.
